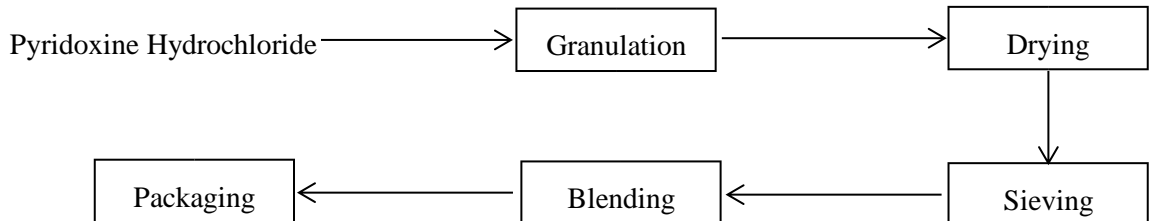


Product Flow Chart
